## Official Vendor Application

### Application Requirements:

All crafters, including those sharing a booth, must send either a description or photo of merchandise to be sold during the event, along with the appropriate fee and completed registration form on the next page. **Please include a stamped, self-addressed envelope for your acceptance response.** Your fee is refundable only if we do not accept your entry.

### Craft requirements:

We prefer items be handcrafted by the participating artist but we will allow imports and some commercial items.

### Booth requirements:

Participants must bring their own booth and furnishings, cinder blocks to secure tent, fire extinguisher, trash container lined with plastic, LIGHTING and ELECTRICAL CORDS. Booths should be designed to withstand all weather conditions. No security is provided, so vendor is responsible for their own security. There is 110v 15amp power available but not guaranteed. **For more than 30 amps you need to bring your own generator.**

### 10' X 10" Booth fees for the 3 day event weekend:

Non-Profit - \$75

Arts & Crafts - \$125

Commercial and Food - \$250

**Booth set up times:** Friday 8:00a.m. – 3:00 p.m.  
Saturday & Sunday: 6:00 a.m. – 9:00 p.m.

### Booths are required to be set up for all Event Hours:

Friday, 3:00 p.m. – 9:00 p.m.

Saturday, 9:00 a.m. – 9:00 p.m.

Sunday, 9:00 a.m. – 6:00 p.m.

### Booth Tear Down:

All booths must be left up until at least 9:00 p.m. on Friday, Saturday and 6:00 pm on Sunday. Vehicles are not allowed into the booth area until 6:00 p.m. on Sunday. Please do not pack up before 6pm.

Vehicles may be driven to the booth space during set up and tear down times, but must park in vendor parking at the Mill Site. No cars will be allowed in the booth area after event opens. Streets will be closed to all through traffic for all three days during the event times. Please keep your area neat and clear of debris.

Vendors will conduct their own sales and collect/report tax for each sale as required by the Washington State Department of Revenue.

Vendors shall indemnify and hold harmless the Management of Old Mill Days, the town of Port Gamble, and Olympic Property Management from and against any and all claims, damages, losses, or injury to person, and expenses including attorney's fees arising out or resulting from the activities of the vendor, or the officers, contractors, licensees, agents, servants, employees, guest, or visitors, or vendors.
